



Flls book profit, metal, IT and auto sectors tumble.

Nifty witnessed a profit booking during Friday's trading session and closed with a decline of 82 points. On its daily chart, price is showing a range bound movement while holding above the 20 DEMA support which is currently placed at 24630. As we head into Monday's trading session, 24500-25100 would be the immediate range for Nifty while a breakout of the same shall provide a clarity on further course of action.

INDEX VIEW: BANK NIFTY





Index re-bounds as PSU banks rally.

On the back of PSU banking stocks, the Bank Nifty index witnessed a sharp recovery from lower levels and closed with a gain of 203 points on Friday. On the daily chart, price can be seen consolidating within a horizontal channel while holding on to the 20 DEMA support which is currently placed at 55020 level. Going into the week, 53500 and 56000 is seen as the broader range for Bank Nifty. From an intraday perspective for Monday, 55000 shall be acting as an important support.
