



Index expected to show a range bound activity on the weekly expiry.

Market traded with high volatility on Wednesday as Nifty witnessed swings in both the directions, eventually closing with a gain of 129 points. Price managed to hold on to the previous day's low around 24700 post a sharp rejection from 24950. Going into the weekly expiry today, 24500-25000 is seen as the broader range for Nifty while the sideways momentum is expected to sustain. 24700 is expected to act as an immediate support. We hold a cautious view on Nifty with a recommendation to avoid aggressive buying.







Index continues to hover around 55000 level.

Post a sharp rejection from 55300 levels, Bank Nifty managed to bounce back from the day's low around 54700 and eventually closed above 55000. On its daily chart, the index has witnessed a 'doji' candle formation indicating indecisiveness among the buyers and sellers. For Thursday's trading session, 54500 is seen as an intraday support while a breakdown below the same might lead to an extended correction of 300-500 points. At the higher end, resistance is expected at 55300.
