



INDEX VIEW: NIFTY






Index surges above 24800 as FMCG stocks gain.

Market traded with a bullish momentum on Friday as Nifty gained nearly 250 points and closed around 24850 level. On its daily chart, price can be seen bouncing back from the 20 DEMA support post a short-term profit booking. Heading into the week, we see 24000-25500 as the broader range for the index. The positive momentum is expected to continue on Monday's trading session with price heading towards 25000 level. 24800 is seen as an immediate support.

INDEX VIEW: BANK NIFTY





Index hovers around 55000 while bias remains positive.

Bank Nifty gained bullish momentum on Friday and surged by nearly 500 points. On its daily chart, the index can be seen trading within a corrective channel with lack of clarity among the buyers and sellers. 54000-56000 shall be acting as the broader range for the upcoming week. Considering Monday's trading session, a positive bias can be maintained on the index with 55200 as an intraday support. On the contrary, 56000 would be acting as a decisive hurdle.


