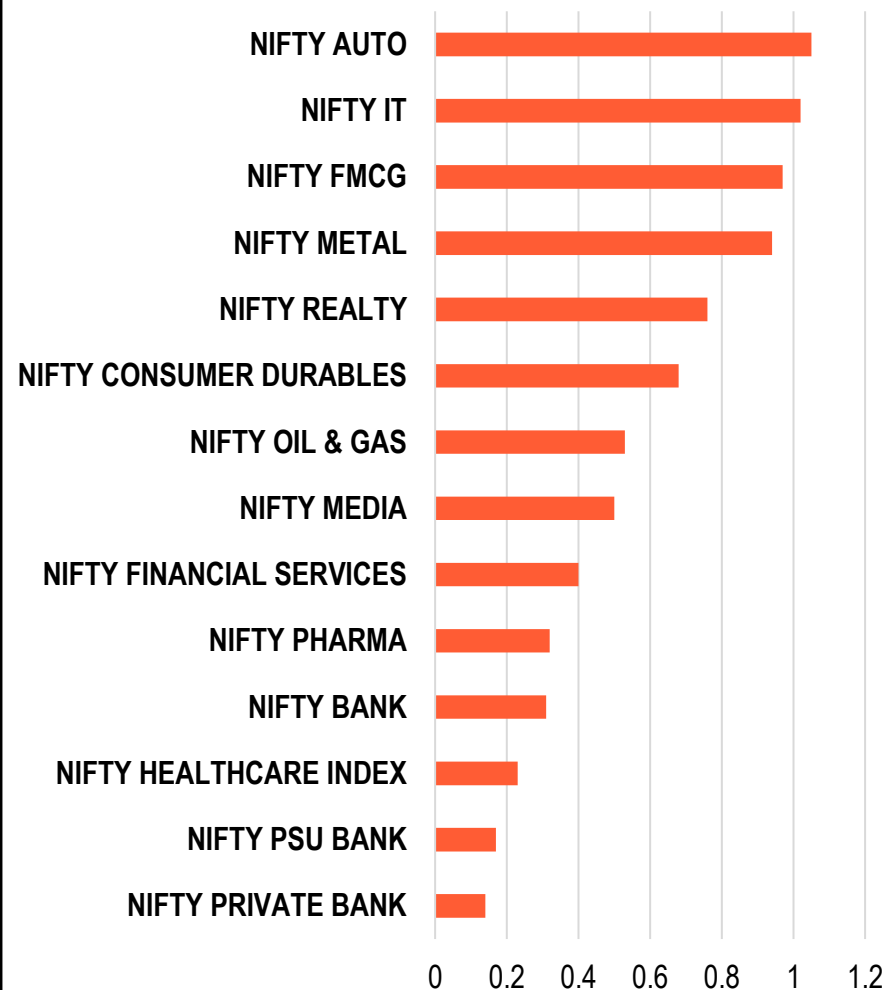

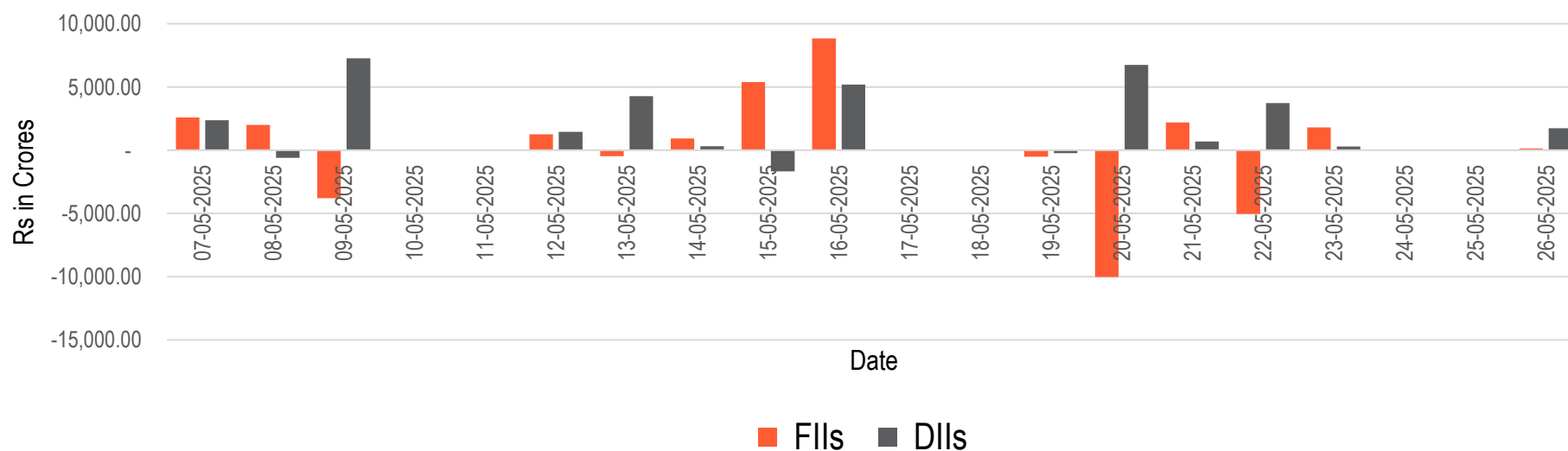

Nifty gains nearly 150 points amid buying across sectors.

As of May 27, 2025, the Nifty 50 index maintains a bullish stance, having closed at 25,001.15 on May 26, marking a 0.60% gain. The index has broken out of its previous consolidation range of 24,500–25,000, signaling potential for further upward movement. Immediate resistance is identified at 25,200, while support is seen at 24,800. Technical indicators such as the RSI oscillator at 61.45 suggest healthy momentum without overbought conditions. On Tuesday's trading session, a decisive move above 25,200 could pave the way toward 25,400–25,600 levels, whereas a drop below 24,800 might trigger consolidation or correction.



INDEX VIEW: BANK NIFTY



Index continues to consolidate as traders lack clarity.

As of May 27, 2025, the Bank Nifty index closed at 55,572, marking a 0.3% gain, driven by strength in private sector banks like IndusInd Bank and ICICI Bank. Technically, the index seems to be consolidating within a broader range while the 'Doji' formation on Monday indicates indecisiveness among buyers and sellers. As we head into Tuesday's trading session, the consolidation is expected to continue and price can be seen hovering within the broader range of 55000-56000. An intraday support lays at 55200 level while resistance stands at 56000 itself. A breakout above the same shall trigger short covering, leading to an extended upward move of 500-700 points.
